

Thirty-Third District PTA Safety Program Recognition and Award

The Thirty-Third District PTA Safety Program Recognition and Award acknowledges the efforts of all units and councils promoting safety awareness and providing educational opportunities for students, parents and the community. This program also provides recognition to units and councils for their outstanding and unique efforts through the Merit Awards and Grand Awards.

Examples of safety programs include but are not limited to: **Transportation** (automobile safety, teen driving, seat belts and car seats, traffic, pedestrian safety, bus, skateboard and scooter safety); **Sports and Recreation** (playground equipment, bicycle, skateboard, scooter, water and all sports); **Emergency Response** (fire protection and prevention, child abduction, earthquake, campus violence, weapons and gang prevention); **Cultural** (teen dating, internet and electronic communication, conflict resolution, bullying prevention, physical abuse, substance abuse, health awareness, waste reduction and recycling).

Note: A "Valet" program is not a PTA approved safety program for insurance reasons.

Red Ribbon Week activities do not qualify for this program.

Safety Award Requirements

Safety programs and activities accepted must be sponsored and conducted by your PTA unit or council during 2011. Qualified programs will be recognized as one of the following:

Safety Program Recognition

- Complete an application that follows the application format exactly
- ♣ Supporting materials (no more than 3 pages of supporting material)

Merit Award

- ♣ All Safety Program Recognition requirements (see above) plus
 - School involvement including other than PTA board members (i.e. teachers, staff, parents and/or students)

Grand Award (granted to one unit and one council)

- ♣ All Merit Award requirements (see above) plus
 - Community involvement

Please follow application requirements exactly. Failure to do so could result in disqualification.
